In case of 3 Phase standby Diesel generator 70, 250 and 600 KVA: Engine must be Komatsu (Japan) / Perkins (UK) / Cummins (USA) / Mitsubishi (Japan) / Volvo (Sweden) / Cater Piller (USA) and Alternator must be Newage Stamford (UK) while the port of shipment must be Japan, USA, UK or any European country. In case of 3-phase standby Diesel Generator 20, 30 and 50 KVA: Engine must be Perkins (UK) / Cummins (USA) / Mitsubishi (Japan) / Isuzu (Japan) / Nissan (Japan) / Volvo (Sweden) / Duetz (German) / Kubota (Japan) and Alternator must be Newage Stamford (UK) / Leroy Somer (France) / Denyo (Japan) while the port of shipment must be Japan, USA, UK or any European country.

The intending suppliers have to apply in their letter head pad and must submit documentary evidence like up to date Trade License, VAT registration Certificate, Up to date Tax clearance certificate, Distributorship/ Local agency of the mentioned item. Manufacturer must submit trade license where it will be clearly mentioned that they are the manufacturer of the item to be offered. Experience Certificate/Performance Certificate of the company from local clients. **On being satisfied with the documents submitted by the applicant, Tender Schedule will be sold to the intending Bidders** during office hours from November 05, 2013 to November 17, 2013 on payment of **Tk.2,000/-(two thousand)** only in cash (non refundable). No Tender document will be issued/ received by mail.
