

NOTICE INVITING TENDER

ISLAMI BANK BANGLADESH LIMITED invites sealed Tenders from bonafide Bangladeshi Interior Contractor(s) having wide experience in Internal Construction and other related works for performing of Internal construction and other related works under the following conditions:

1. **Name of work:** Internal Construction and other related works of proposed 4 (four) new branches at Comilla Cantonment (Comilla), Mathbaria (Pirojpur), Sonatola (Bogra) and Nikunja (Dhaka), Internal Construction, shifting & other related works of Agargaon Branch, Dhaka & Internal construction & other related works of Assets Management Division (AMD), Head Office situated at Bank's own property at 28, Dilkusha C/A, Dhaka.
