- b) Bangladesh Securities and Exchange Commission (BSEC) Notification No.SEC/CMRRCD/2009-193/07/Admin/106 dated 01 September 2020 to hold the 43rd Annual General Meeting (AGM) through physically.
- c) A member eligible for participating and voting at the Annual General Meeting may appoint a proxy on his / her behalf.
