- Eligibility:**

In order to participate, bidders must qualify by meeting the following criteria:

- Bidder should be an OEM authorized Local Agent /reseller/partner of the product with functional service/support centers. Experienced and recognized Bidder will get preference. OEM Authorization letter to supply the offered solutions to IBBL must be submitted. Manufacturer's Authorization Certificate (directly issued by the OEM; not via any Distributor) with a mention of the Purchasing/Tender Authority's name and authorization letter must mention clearly the tenure of the partnership.
- The bidder should not have been blacklisted by any Government/Private Institutions in the country and abroad. A self-declaration letter by the Bidder on the Company's letterhead should be submitted along with the technical bid.
- The proposed solution's local bidder must be a registered company in Bangladesh having proven and substantial market presence for selling IT security solutions (Endpoint Security, SIEM, NGFW, NGIPS, WAF, NBA, etc.) in the last 2 years in Financial sector in Bangladesh.
- Bidders must possess the necessary professional and technical qualifications and competence, financial resources, equipment and other physical facilities, including after-sales service where appropriate, managerial capability, experience in the offered solutions, reputation, and the personnel, to perform the contract.

- e) Bidders must have the legal capacity to do business in Bangladesh and enter into a contract with IBBL.
- f) Bidders must show that they are not insolvent, in receivership, bankrupt or being wound up, their business activities have not been suspended, and they are not the subject of legal proceedings for any of the foregoing.
- g) Bidders must show that they have fulfilled their obligations to pay taxes and other contributions under the relevant national regulations.
- h) The bidder shall be the single point of contact for IBBL and shall be solely responsible for all maintenance, warranties, up gradation and guarantees etc. offered by OEM. An undertaking to this effect should be submitted by the bidder.
- i) The bidders have to provide valid Manufactures Authorization Form (MAF), up-to-date Trade license, up-to-date Income Tax certificate and VAT registration certificate.

Bidders have to provide appropriate documentary evidence or other information to demonstrate that they are qualified in accordance with the criterion mentioned above. In order to be awarded by the Bank the bidder must have to meet all criteria mentioned above. Decision of IBBL will be final in this regard and no appeal would be accepted.

- a) A copy of the Manufacturer's Authorization Letter (MAF) clearly stating the partnership type and duration with OEM to be attached with the technical offer.
- b) Attested copy of Certificate of Company Incorporation (in case of limited company).
- c) Attested copy of valid up-to-date Trade License,
- d) Attested copy of up-to-date Income TAX certificate and VAT certificate.
- e) A brief Company Profile along with list of Clients with contact information.
- f) IT Security project completion certificates in the financial industry stating specifics, scope and extend of work done.
- g) CV (as per attached format in annexure-II) of concerned technical personnel available for installation, commissioning, maintenance of Hardware / Software.
- h) Authorized document stating the time and extend of after sales Technical Support to be provided by the OEM for the proposed product.
- i) Full sets of original catalog / leaflets, brochures, literature, etc. mentioning detailed technical and general specifications of the respective solution.
- j) Detailed Project Implementation plan of the solution stating time frame and work required.
- k) Authorized document stating the time and extend of after sales Technical Support to be provided by the OEM for the proposed product.
