1. **Name of work:** Invitation Tender for providing 5 (five) years license, installation, configuration, deployment, updating and technical support for Two Factor Authentication Solution for 200 users in SWIFT operation of IBBL.

On being satisfied with documents submitted by the applicant, Tender document will be sold to the intending bidders.
