ISLAMI BANK BANGLADESH PLC invites sealed Tenders from bonafide Bangladeshi Interior Contractor(s) having wide experience in internal construction, shifting, repairing and other related works for performing of construction, shifting, repairing and other related works under the following conditions:

1. **Name of work:** (i) Internal construction, shifting and other related works of **Sherpur (Urban) Branch, Sherpur**, (ii) Repairing works of **Agrabad Building (Bank's own property) at 3, Agrabad, Chattogram**.
