

REVISED NOTICE INVITING TENDER

ISLAMI BANK BANGLADESH PLC invites sealed Tenders from bonafide Bangladeshi Interior Contractor(s) having wide experience in internal construction, shifting, repairing and other related works for performing of construction, shifting, repairing and other related works under the following conditions:

1. **Name of work:** (i) Internal construction, shifting and other related works of **Sherpur (Urban) Branch, Sherpur**, (ii) Repairing works of **Agrabad Building (Bank's own property) at 3, Agrabad, Chattogram**.
2. **Eligibility:** Specialization in the related field and having past experience in completion of similar works at Bank and its allied concern of minimum Tk.20.00 lac in a single tender. The intending Tenderers will have to purchase the Tender Document from the office of the undersigned by applying in their letterhead pad well ahead before the last date of tender selling along with the following documentary evidence:
 - a. For evidencing 05 years past experience, previous Trade License & completion of the related works shall have to be submitted as proof.
 - b. Work experience & clients list with detail address, contact person & Telephone number.
 - c. Updated Trade License, VAT Registration Certificate, up to date Income Tax Clearance Certificate and Bank Solvency Certificate.
3. **Place, time and availability of Tender Document:** Tender documents will be issued to the intending Tenders on cash payment of Tk.3,000.00 (Taka Three thousand) only (Non-refundable) **for each schedule** on working days from the office of the undersigned during office hours from 29 July, 2024. to 07 August, 2024.
4. **Earnest Money:** 2.5% (two point five percent) of the total Tender amount in favour of Islami Bank Bangladesh PLC in the form of Bank Draft/Payment Order from any Scheduled Bank preferably from any branch of Islami Bank Bangladesh PLC must be submitted along with the Tender without which the Tender shall be rejected outright.
